

Competition Terms and Conditions: Hannah Laing DOOF Ibiza Waitlist Competition 2024

Eligibility:

1.1 The "Hannah Laing DOOF Ibiza" competition (the "Competition") is open to individuals aged 18 years and older at the time of travel.

1.2 Employees, agents, and immediate family members of IRG (Ibiza Rocks Group) or Hannah Laing are not eligible to participate in the Competition.

1.3 Participants must have a valid passport and be eligible to travel to and from Ibiza.

Entry Period:

2.1 The Competition entry period begins on [Start Date] 2024 and ends on [End Date] 2024.

2.2 Entries received after the specified end date and time will not be considered.

How to Enter:

3.1 To enter the Competition, participants must fill out the online entry form to join the event waitlist. This is available on the waitlist landing page <https://pages.viral-loops.com/doof-ibiza-2024>.

3.2 Only one initial entry per person is allowed. Duplicate entries will be disqualified.

3.3 Participants must provide accurate and complete information on the entry form.

Winner Selection:

4.1 The winner will be selected at random from all eligible entries received.

4.2 The draw will take place on [Draw Date] 2024 by the IRG team, and the winner will be notified using the email address provided in their entry within 48 hours.

4.3 If the winner cannot be contacted or does not reply to claim the prize within 1 week of being contacted, an alternative winner will be selected through a subsequent random draw.

Prize:

5.1 The prize for the Hannah Laing DOOF Ibiza Trip Competition includes:

- A trip for 3 people to Ibiza, staying at Ibiza Rocks Hotel for 3 nights over the date of the Hannah Laing DOOF Ibiza event only.
